The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Other funeral service providers may provide certain funeral services off premises.

**I. PROFESSIONAL SERVICES OF FUNERAL DIRECTOR AND STAFF**

**BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF**.....\$ 2,235.00

Our fee for the services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service, arrangement conference with family or responsible party, arrangement of funeral ceremony, preparation and filing of necessary authorizations and permits, temporary shelter of remains, recording vital statistics, preparation and placement of obituary notices and staff assistance prior to, during and following the funeral ceremony including coordination with those providing other portions of the funeral ceremony, e.g. cemetery, crematory and others.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

**II. OTHER SERVICES**

**A. FUNERAL HOME FACILITIES**

- 1. Facilities and Staff for Visitation.....\$ 475.00  
Our fee includes a funeral service professional to coordinate set-up of visitation area, use of our facility or travel to another facility, and supervision of public visitation by funeral home staff.
- 2. Facilities and Staff for Private Gathering of Immediate Family.....\$ 350.00  
Our fee includes a funeral service professional to coordinate set-up of gathering area, use of our facility for one hour, and supervision of gathering by funeral home staff.
- 3. Facilities and Staff for Funeral Ceremony.....\$ 575.00\*  
Our fee includes a funeral service professional to coordinate set-up of funeral area, use of our facility or travel to another facility, travel to gravesite, and supervision of ceremony by funeral home staff.
- 4. Facilities and Staff for Memorial Ceremony (without remains).....\$ 575.00\*  
Our fee includes a funeral service professional to coordinate set-up of memorial area, use of our facility or travel to another facility, and supervision of ceremony by funeral home staff.
- 5. Funeral Home Owned Equipment and Staff for Graveside Ceremony.....\$ 575.00\*  
Our fee includes a funeral service professional to coordinate set-up of graveside area, travel to gravesite, and supervision of ceremony by funeral home staff.
- 6. Facilities and Staff for Reception.....\$ 650.00  
Our fee includes a funeral service professional to coordinate set-up of visitation area, use of our facility, supervision of reception by funeral home staff, and clean up.

**B. EMBALMING**

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

C. OTHER PREPARATION OF REMAINS

- 1. Dressing and Casketing Embalmed Remains..... \$ 200.00
- 2. Dressing and Casketing Unembalmed Remains..... \$ 250.00
- 3. Basic Care of Unembalmed Remains (when embalming is not requested)..... \$ 300.00\*  
Our fee includes bathing, disinfection, and refrigeration of remains.
- 4. Refrigeration of Remains (when embalming is not requested) ..... \$ 300.00\*

\* A fee of \$75.00 per day will be added for refrigeration of remains beginning with the 4th day.

D. IMMEDIATE BURIAL..... \$ 3,410.00 to \$11,985.00

Our fee includes basic services of funeral director and staff, local removal of remains, refrigeration of remains, and local transportation to the cemetery. This fee does not include a casket or attendant services.

- 1. With Casket Provided by Purchaser ..... \$ 3,410.00
- 2. With Casket to be Purchased (sales tax to be added) ..... \$ 3,410.00
- 3. With Highest Priced Casket (sales tax to be added) ..... \$ 11,985.00

E. DIRECT CREMATION..... \$ 3,035.00 to \$ 11,610.00

Our fee includes basic services of funeral director and staff, local removal of remains, refrigeration of remains and crematorium charge. This fee does not include a casket, alternative cremation container or attendant services. Certain conditions may require additional third party fees.

State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).

The containers we provide are constructed of cardboard.

F. TRANSFER OF REMAINS TO OUR FUNERAL HOME

- 1. Within Local Area (1-19 miles)..... \$ 500.00
- 2. Within Surrounding Area (20-45 miles) ..... \$ 525.00
- 3. If transportation is required beyond stated surrounding areas (45+ miles), we charge a flat rate of \$525.00 for the first 45 miles plus \$2.50 for each additional loaded mile.

G. TRANSFER OF REMAINS TO ANOTHER LOCATION

- 1. Transportation Within 45 miles ..... \$ 525.00
- 2. If transportation is required beyond 45 miles, we charge a flat rate of \$525.00 for the first 45 miles plus \$2.50 per each additional loaded mile.

H. FORWARDING REMAINS TO ANOTHER FUNERAL HOME ..... \$ 4,245.50

Our fee includes basic services of funeral director and staff, local removal of remains, normal embalming, dressing of remains, air tray with sales tax, and transportation to Norfolk International Airport. This fee does not include a casket or attendant services.

I. RECEIVING REMAINS FROM ANOTHER FUNERAL HOME ..... \$ 3,135.00

Our fee includes basic services of funeral home and staff, transportation from Norfolk International Airport, and local transportation of remains to cemetery. This fee does not include a casket or attendant services.

3. Transportation Beyond Surrounding Areas

If transportation is required beyond stated surrounding areas, we charge a flat rate for the first 45 miles plus an additional loaded mile fee.

- a. Hearse \$400.00 flat rate for first 45 miles plus \$2.50 per additional loaded mile
- b. Utility Vehicle \$350.00 flat rate for the first 45 miles plus \$2.00 per additional loaded mile

In most areas of the country, state or local law does not require that you buy a container to surround the casket in the grave. However, many cemeteries require that you have such a container so that the grave will not sink in. Either a grave liner or a burial vault will satisfy these requirements.
